## Bella Debutante Terms & Conditions 2026



By submitting your registration form for a Bella Debutante Date, it is not secure without a deposit and or full payment.

By paying your registration payment you will secure your spot.

FULL Registration payment must be paid 90 Days before said date of the Event.

Due to lack of numbers, Bella Events reserves the right to combine numbers to another date suitable. If new date does not work for you. You will receive a refund.

Bella Events run their balls based on participation of Debutantes and partners.

Our new Limit as of 1<sup>st</sup> January 2026 is 12 debutantes & Partners. We can also take 10 couples.

Please think carefully about a mere change of mind. Your commitment to a date and the inability to proceed may have a large impact on the others in the group. If you are struggling to find a partner, please reach out. We have allot of past partners, willing to be a part of another ball.

By placing a tick on the Registration paperwork, you agree the Bella Terms and conditions and that all information you have supplied us is correct.

**TRAINING:** It is compulsory you and your partner attend all 5 training sessions, as well as rehearsal and any other catch-up lessons or changes provided by Bella Events trainer. If training must move to another night due to the training hall being unavailable, you will need to be available on the change of night.

Bella Events asks you ensure, work, sport, social commitments are put aside whilst training for 5 weeks leading up to the debutante ball.

Bella Events reserves the right to remove Debutante and or both/ partner from the training event if little or no effort is made. Disrespectful, inappropriate behaviour, bullying, disruption, under the influence of drugs or alcohol, violence or threatening behaviour. In this instance, you will NOT receive a full refund (IF) asked to leave the group. If you find a new partner, the full registration still applies, and the dance trainer will provide extra training to get the new partner up to speed.

In the case of a student mentor stepping in to partner the debutante for the event, the debutante will need to pay for the cost to hire the suit.

By placing a tick on the Registration paperwork, you agree the Bella Terms and conditions and that all information you have supplied us is correct.

**SUIT HIRE:** The payment for your suit is not covered in your registration payment. This is an additional cost.

A hire agreement is given to the debutante partner, and all moneys and contract for the suit hire will be with FERARRI formalwear Albury.

By placing a tick on the Registration paperwork, you agree the Bella Terms and conditions and that all information you have supplied us is correct.

**THE EVENT**: If in the case of a cancellation of Event by public health order, the registration and tickets sales will be fully refunded.

Tickets to the event must be shown at the door. No ticket, no entry. There are no pass outs. Once you leave the Event you are unable to come back into the Event. In the case of smoking or vaping, you are required to go outside. No patron under the age of 18 is to leave the event or wonder around the club without the supervision of an Adult as per SS&A club legislation. Children under 18 must be accompanied by an Adult while in the SS&A Club.

Seating will be made up of round tables of 12 people per round table. You and your partner will be able to purchase another table of 12. Between you and your partner you will have 22 seats to sell as 2 seats belong to you and your partner. Whilst it is Bella Events priority to ensure all debutantes, and partners families are positioned close to the dance floor, your extra table will be positioned elsewhere in the Auditorium as organisers discretion.

From 00:01am Monday the week of the ball final numbers will be submitted. If in the case you have someone unable to attend, it is your responsibility to find s replacement for that seat, as long as there is no dietary requirements.

Children under the age of 3 are admitted into the event free of charge. No meal will be supplied and no highchairs available due to OH&S. The child may sit on your lap. There is limited space for prams.

Whilst in the club, we are bound by club rules. Security is provided by the SS&A Club and will remove patrons, if found intoxicated or under the effect of drugs. Underage drinking, vaping inside the event, under the influence of drugs and the supply of alcohol to an underage person will be escorted out of the venue by security.

There is no naked flame, confetti, glitter type product or balloons no alcohol or alcohol type products to be bought into the venue.

Bella Events provides basic table decorations. Any guest favours will need to be individually wrapped, boxed or in containers. No open food is to be left on the table for your guests such as nibbled, chips, opened lollies etc.

Your tables must be cleared at 10.45pm make sure you remove rubbish to the bins provided and remove keepsakes from the tables. Any lost property will be held by Bella Events. If not collected it will go to a charity.

SS&A Club may have an increase of price by July 1<sup>st</sup>, 2026. These will be passed on in writing if this is the case.
